The discussion of this meeting focused on determining the priorities for the Bipartisan Infrastructure Law (BIL) funds.

- To avoid conflicts of interest the subcommittees will be taken out of the selection process. If ranking of the projects is required, the representative subcommittee member will not be able to rank their own.
- The funds will be directed towards big collaborative projects that GBEP cannot normally fund; benefit GBEP and the watershed. Projects will ultimately be

decided upon by the B&P subcommittee and presented to the GBC.

- Projects should be a minimum of \$150,000 with a length of three years or less.
- Projects that address multiple priorities of the Galveston Bay Plan should be considered more highly.
- Projects that focus on EPA areas of special interest should be prioritized.
- Projects with a sense of urgency should be prioritized.

The B&P subcommittee members decided to have the PPE, M&R, WSQ, and M&R subcommittees each decide on a list of priorities that are important to them. The B&P subcommittee will then review each list and choose priorities.
