Call to Order

Approval of the June 14, 2023 minutes - Ms. Rines opened the meeting with approval of the minutes. Ms. Glenn motioned to approve the minutes and Mr. Johnston seconded the motion. The minutes were approved with no changes.

A Conflict-of-Interest statement was emailed out prior to the meeting. Subcommittee members were asked to sign the statement and disclose any interest with a proposed project prior to or during the project nomination discussion. All possible conflicts of interest were captured in the meeting's recording and chat feature.

New Business

FY 25 Project Proposals and Discussion

Project proposals were sent out in advance of the meeting for review. Members were asked to keep the subcommittee priorities in mind while reviewing.

The priorities selected by the WSQ Subcommittee for the FY23 finding cycle were:

- Supporting management measures and watershed-based plans
- Monitoring and research that evaluates GI effectiveness in water quality and soil health
- Targeted/Direct Monitoring

Each person presenting a proposal was given a total of 5-7 minutes to explain their project followed by a few minutes for Q&A. Guidelines for presenting proposals were as follows:

- Due to time constraints, presentations were limited to a few slides;
- Proposals were presented in the order of the distributed project proposal packet;
- If a connection to a proposal was not obvious, the relationship to the project was disclosed; and,
- If a vote was necessary, only one person from each entity could vote and represent their entity.

Once all proposals had been presented to the group, the subcommittee discussed which projects should take priority. A consensus-based decision was made to recommend three projects for FY25 funding to the Budget and Priorities (B&P) Subcommittee. A third and fourth project were recommended as alternatives if any funding becomes available, with priority given to the first alternate. Projects selected by the B&P Subcommittee would be presented to the GBC at the October council meeting for approval. The following project proposals were recommended by WSQ subcommittee members:

If additional funding does become available, the recommendation is to put the remainder of that money towards supporting the first alternate project, "Watershed Protection Plan Development for Greens Bayou," highlighted in red. Any additional funding beyond \$30,000 could help support the second alternate project, "Distribution of key emergent pollutants in the aquatic biota (oysters and fish), sediments and surface waters of Galveston Bay."
