NRU Subcommittee Bylaws Discussion

Lindsey Lippert asked the subcommittee to evaluate potential changes to the NRU Bylaws based on changes to operating procedures since the past update. The original bylaws and proposed updates (via a track changed Microsoft Word document) were distributed via email before the meeting and hard copies were available at the meeting. General changes addressed were related to formatting to be consistent with Galveston Bay Council Bylaws, clarification on voting actions within the NRU subcommittee, and updates to the "Workgroup" section (specifically related to the formation of workgroups and documenting existing workgroups) of the NRU Bylaws.

Discussion within the subcommittee further refined language regarding matters of voting, attendance, and what constitutes a "member organization" were addressed via a working version of

Of note, one issue brought to the subcommittee that could not be addressed was limiting the indirect rates of entities during the project planning process. Unfortunately, this is an issue that must be handled through TCEQ's Legal and Contracts departments, and cannot be addressed through subcommittee bylaws.
