#### PPE Subcommittee Bylaws

Zoe Gapayao shared the updated version of the PPE Subcommittee bylaws that included changes addressed in the December 2024 subcommittee meeting. Ms. Gapayao reminded the subcommittee that these changes were regarding the ability to rank projects seeking funding in September. The first addition is that subcommittee members must attend two of the four subcommittee meetings prior to the September meeting. Both in-person and virtual count towards attendance and a proxy can be sent if the member is unable to attend. The second addition is that member organizations have one ranking vote, so all individuals from one member organization must come to a consensus about their collective ranking. David Sharp pointed out that there were mistakes found in the Member and Member Organization List and Attendance. Ms. Gapayao assured the subcommittee that she would make necessary corrections to the list.

## Engaging Diverse Communities in Conservation 2024 Updates

Morton Sager of BPA gave the subcommittee an update on a PPE project that is now on its second phase. BPA will partner with Greens Bayou Coalition, White Oak Bayou Association, and Citizens' Environmental Coalition to help enhance outreach and community conservation by building capacity in small, volunteer-led or board-run organizations. BPA is collaborating with partners to create the parameters of their internship program and job description. In its second phase, this project is called Engaging Under-resourced Communities in Conservation.

#### Latino Outdoors Houston Chapter

Valeria Hernandez, a dedicated volunteer with Latino Outdoors (LO), shared about the national organization and their local efforts. LO inspires, connects, and engages Latino communities to the outdoors in safe and inclusive ways. Ms. Hernandez shared the core values of LO and the importance of sharing and celebrating stories, knowledge, and culture through their events. #### PPE Subcommittee Bipartisan Infrastructure Law (BIL) Priorities

Ms. Gapayao informed the subcommittee that this will be the last year of BIL funding for which we have around \$900,000.00 leftover for Federal Fiscal Year (FFY) 26. After reviewing Galveston Bay Plan priorities and action plans, the subcommittee looked over previous years' BIL priorities. The subcommittee agreed on the three FFY 26 PPE Priority Recommendations: 1) Engaging K-12 students and/or adults in hands-on, place-based environmental education 2) Includes region-wide initiatives/collaborations that implement the Engage Communities priority plan and 3) Fostering collaborations and/or building capacity with new communities and organizations.
