#### **Call to Order and Confirm Quorum**

Bob Stokes brought the meeting to order at 9:32 a.m.

#### **Introductions**

Mr. Stokes began by having the GBC members introduce themselves. Introductions began with in-person attendees, followed by members attending virtually.

Mr. Stokes reminded the GBC that virtual attendance is not included in the quorum. The quorum was met for this meeting.

**Action Item: Approval of July 16, 2025 Meeting Minutes**

Mr. Stokes called for approval of the July 16, 2025, meeting minutes. Dianna Ramirez motioned for the approval and Jonathan Holley seconded the motion. The minutes were approved unanimously with no opposition or abstentions.

### **Report of the Program**

Lisa Marshall reminded all members that if they had not done so already, to please sign the conflict-of-interest form. She also reminded anyone with a conflict of interest to please note that during the voting discussions. Members online were asked to submit the form to Ms. Marshall before the end of the meeting.

Ms. Marshall announced that registration for the State of the Bay Symposium opened at 9:00 a.m. on Oct. 15, 2025, and that hotel reservations are also available online. She also noted that a GBC member dinner will be held the evening before the symposium, and more details would be sent out soon.

Ms. Marshall then provided an update on the dates for the 2026 GBC meetings, which will be on January 21, April 15, July 15, and Oct. 21, 2026.

Lastly, Ms. Marshall stated that while the new chair and vice chair will be nominated later in the meeting, she would first like to thank Mr. Stokes for his work as the GBC chair for the past two years. She noted that he has been an advocate for GBEP and the GBC and has consistently championed the mission and work of GBEP. His support has been instrumental in supporting increased funding and visibility and we are sincerely thankful for this.

### **Report of the Chair**

Mr. Stokes thanked the GBC members and GBEP staff for their work and stated it had been an honor to work with the GBC and GBEP staff throughout his career and as the GBC chair for the past two years.

Mr. Stokes then introduced Molly Powell as the new GBC representative from Port Houston. Ms. Powell then provided a brief introduction and background on herself for the GBC.

Mr. Stokes then announced that Vance Darr has accepted the nomination to be the new chair of the GBC and Elizabeth Fazio Hale has accepted the nomination to be the new vice chair.

Mr. Darr provided the biography of Ms. Fazio Hale and Ms. Fazio Hale said this is an honor and that she looks forward to serving as the vice chair. Mr. Darr then provided his background for the GBC.

Mr. Stokes then called for a joint motion for Mr. Darr to be the GBC chair and Ms. Fazio Hale to be the vice chair. Brian Koch made the motion, and Rusty Senac seconded the motion. The motion passed unanimously.

**Presentation:** *Long-term Monitoring of Living Shorelines* – James Dobberstine, Ph.D., Lee College

Jim Dobberstine, Ph.D., provided an overview of the long-term research that he and his students have been conducting on living shorelines around Galveston Bay. Dr. Dobberstine began with a background on the erosion issues around Galveston Bay along with the types of typical shoreline armoring used. Next, he discussed the history of shoreline loss around Galveston Bay and then provided insight into alternative shoreline

protection processes. This research involves monitoring living shorelines, specifically areas that also have nearby locations that are traditionally armored and unprotected areas. The remainder of the presentation highlighted the work that has been done to evaluate the benefits of small-scale restoration projects for the purpose of adaptive management.

Jeff DallaRosa asked if they investigated any of the restoration work done by Cheri O'Brien in Christmas Bay. Dr. Dobberstine replied that there was significant literature review done for this project, but many places did not meet the criteria of having both positive and negative controls near to the restoration site. Lindsey Savage commented that Texas Parks and Wildlife Department (TPWD) are currently doing habitat surveys and new imagery, and data will be available soon.

Albert Gonzales asked if there was insight into what the sources would be of microplastics in Trinity Bay. Dr. Dobberstine stated they were not sure, but that they noticed that microplastics were more prevalent upstream (in the bayous, in the northern part of the bay) and the amount decreased as the samples got closer to the Gulf.

Mr. Senac asked for recommendations to help areas where previous projects had failed. Dr. Dobberstine commented that it is difficult because there are a variety of metrics that impact the severity of erosion, and that additional engineering and modeling is sometimes necessary to determine the best method to proceed. Another option is to use multiple barriers in a high energy environment, similar to a dune system, to help protect the area. Dr. Dobberstine then suggested contacting Jeffrey Fato at the Galveston Bay Foundation and that the Texas General Land Office (TxGLO) also has some useful resources.

**Presentation:** *Getting to Know Council Member Jeff DallaRosa* - Jeff DallaRosa, CenterPoint Energy, Utilities Representative

Jeff DallaRosa provided his background and a brief introduction to the GBC before starting his presentation. Mr. DallaRosa began his professional career with GBEP in 2000 and left in 2010 to join CenterPoint Energy. He currently manages the ecological group on the electrical side for the Houston region and works in the avian protection program. Mr. DallaRosa then provided a background on CenterPoint in the region and his role with the company. He highlighted several projects that relate to the GBC and its partners.

Mr. Stokes asked if the eagles used the relocated nest. Mr. DallaRosa replied that the birds used a different nest for a few years before moving back into the relocated nest in 2014.

Mr. Gonzales asked if there have been any problems with alligators with the decrease in rainfall and Mr. DallaRosa replied that they have had issues in the past, but none recently.

**Dianna Ramirez (TxGLO):** The TxGLO Coastal Roundup will be on East Beach in Galveston on April 18, 2026.

The Coastal Management Program request for proposals will open on March 1, 2026.

The Jones Bay Bird Island project and the Baytown Nature Center oyster reef project both were completed recently, and the Rollover Pass Bird Island project is in pre-bid.

**Jonathan Holley (HCFCD):** Harris County Flood Control District (HCFCD) is accepting feedback on the Harris County Flood Resilience Plan. Additional information is available on the [HCFCD website](#).

**Brian Koch (TSSWCB):** The Texas State Soil and Water Conservation Board (TSSWCB) received 30 proposals for funding through Section 319. The proposals are being reviewed at this time, and selected applicants will be contacted in the next few months.

**Kelly Mills (TCEQ):** TCEQ has had some recent leadership changes. Bobby Janecka's time as a commissioner has ended and Governor Abbott appointed Tanya Miller as a new commissioner, effective Oct. 1, 2025. Mr. Mills also invited everyone to register for the upcoming State of the Bay Symposium.

**Dr. Amin Kiaghadi (TWDB):** The Texas Water Development Board (TWDB) also has had recent leadership changes. Bradley Franks and Ashley Morgan both joined the TWDB and Tanya Miller was appointed as a commissioner at TCEQ.

TWDB also has two stakeholder opportunities to submit project ideas. These are not funding opportunities but are ideas for future projects. The first is related to flood planning and flood science and is open through Oct. 31, 2025. The second opportunity for projects to advance surface water science closes on Oct. 15, 2025.

TWDB also has a new [video on their website](#) that shows TWDB and the U.S. Geologic Survey deploying and monitoring a buoy in Trinity Bay.

**Antonya Harris (USACE):** The Coastal Texas Project, Section G28, is in the design phase to create a small four mile section of breakwater along the Gulf Intracoastal Waterway adjacent to Bolivar Peninsula to prevent erosion and restore habitat.

For segment S2G Orange (Sabine to Galveston Bay Coastal Storm Risk Management Project), the open comment period closed on Oct. 9, 2025, and the report of the Supplements Environmental Impact Statement is expected to be completed in late 2026, at which time it will be open for public comment.
